



Water User Rates - Residential & Commercial Users: effective September 1st, 2014

Bimonthly Water Base Rate & Consumption Charges are calculated as follows:

Water Base Rate x Capacity Multiple + Consumption (over bimonthly 1000 cubic feet included)

Water Measurement Conversion

- Customers receive 1,000 cf (7,480 gals) with the 5/8" meter base rate.
- 100 cf = 748 gals.
- Consumption over 1,000 cf in a billing period is charged at the above tiered rates.

Example: A Standard Residence 5/8" meter using 1,250 cf over 2 months would be charged a total of \$117.16.
 (5/8" Meter Water Base Rate = \$113.56 x 1) + \$ 3.60 (250 cf additional Consumption Charges = 250 / 100 x \$1.44)

Note: The average single-family residence with 3 full-time occupants uses roughly 13,500 gals bimonthly. (1,805 cf bimonthly) resulting in \$11.59 (805 / 100 x \$1.44) worth of added consumption charges. Capacity Multiples are also applied to the tiers and billing (e.g. a 1" meter has a multiple of 2.5 and a bimonthly base rate of \$283.90 (\$113.56 x 2.5) for 2,500 cf (1000 cf x 2.5). The tier 1 would be 2,501 to 15,000 cf, tier 2 would be 15,001 to 30,000 cf and tier 3 would be over 30,000 cf.

Wastewater User Rates: effective September 1st, 2014

Residential Users: Each Single Family Dwelling is charged 1 x the bimonthly sewer rate.

Example: A Duplex, which equals 2 SFDEU's, would be charged: \$ 172.32 x 2 = \$ 344.64 for its bimonthly sewer rate.

Commercial Users: Commercial Customers are charged a Multiple of the Wastewater Rate x SFDEU's (*A SFDEU for this purpose is defined as an amount of sewage equal to 195 gallons per day (gpd) of water usage per unit*). **Example:** A Deli creating 400 gpd of sewage would be equivalent to 2.05 SFDEU's (400 / 195) and would be charged: \$ 172.32 x 2.05 = \$353.25.

Note: Commercial accounts are reviewed annually and wastewater multiple adjusted according to the amount of water used the prior year OR in the event of a change of use occurs on the property which results in additional use of sewer facilities. The bimonthly sewer charge for Commercial Users is a minimum 1 SFDEU for a business and for each unit or business of a multi-commercial complex.

- Customers are billed every **two** months in arrears.
- The Payment Due Date is noted on your customer statement.
- Reminder notices are mailed the next business day following the statement due date. A \$10 late fee imposed.
- No suspension of base minimum fees under normal circumstances (Res. No. 2008-36 & Res. No. 2010-78).
