RECOMMENDED ACTION:

Motion:______ approving Resolution No. 2015-____ to amend the FY 2015-16 CIP Budget for the Jenny Lind Water Treatment Plant Pre-treatment Facilities Project, CCWD CIP #11092, to fund the FEMA grant local match requirement.

SUMMARY:

In response to the devastating effects of the Butte Fire and resulting degradation of the quality of the District's water supplies at New Hogan Reservoir, the District has applied to the Federal Emergency Management Agency (FEMA) for grant funding to install pretreatment facilities at the plant to remove heavy metals, debris and turbidity from raw water entering the plant that could otherwise overwhelm the plant's existing clarifier, filtration, and backwash systems, rendering them inoperable. Pre-treatment facilities would include pressure filters, absorption materials, and backwashing air blowers located within the footprint of the existing plant. Raw water pumped from the river would pass through the pretreatment facilities prior to entering the existing treatment system. The total project cost is estimated at over \$3.7 million, including design and construction.

The District has been working with FEMA to secure grant funding for the project. On December 9, 2015, the Calaveras County Water District's Board of Directors approved Resolution 2015-63 (attached) which added the Jenny Lind Water Treatment Plant Pretreatment Facilities Project to the Water Capital Renovation and Replacement (Capital R&R) project list and provided \$50,000 in initial funding to complete the grant application phase.

On December 15, 2015, Dave Eggerton, District General Manager, notified the Hazard Mitigation Grants Program Unit of the California's Governor's Office of Emergency Services that the District is committed to meeting the matching fund requirements for the Jenny Lind Water Pre-Treatment Project Hazard Mitigation Grant Program (attached) subject to Board approval. The local matching requirement is currently estimated at \$939,500 and will be funded from reserves in the Water Capital R&R Fund

(Fund 125). In order to fund the local match commitment the FY 2015-16 CIP budget will need to be amended to increase the budget for the Jenny Lind Water Treatment Plant Pretreatment Facilities Project, CCWD CIP #11092, by \$889,500 to a total of \$939,500. Adequate reserves are available in the Water Capital R&R Fund (Fund 125) to fund the required match.

FINANCIAL CONSIDERATIONS:

The total construction/implementation cost is estimated to be over \$3.7 million. The FEMA grant would provide seventy five percent (75%) of the funding, while the District would be responsible for the twenty five percent (25%) local matching funds. The source of the local matching funds would be the District's Water R&R Capital Fund (Fund 125). The associated operational and maintenance costs of the pretreatment facilities are estimated at approximately \$10,000 per year.

In addition to the initial \$50,000 approved by Resolution 2015-63, the Jenny Lind Water Plant Pretreatment Project budget in the Water Capital R&R Fund (Fund 125) will be increased by \$889,500, for a total of \$939,500. Upon Board authorization, the adopted FY 2015-16 CIP Budget will be increased by \$889,500 accordingly.

WHEREAS, with the devastating effects of the Butte Fire that burned more than 52,000 acres of the Calaveras River watershed, the quality of the District's water supplies at New Hogan Reservoir will be adversely affected for decades to come. Large quantities of sediment and debris from the burn area will ultimately reach the reservoir, thus reducing its storage capacity and degrading water quality. The District's Jenny Lind Water Treatment Plant is located immediately downstream of the reservoir on the Calaveras River, serving municipal water supplies to a population of more than 10,000 in the Jenny Lind area; and

WHEREAS, to protect this water supply, the District has applied to the Federal Emergency Management Agency (FEMA) for grant funding to install pretreatment facilities at the plant to remove heavy metals, debris and turbidity from raw water entering the plant that could otherwise overwhelm the plant's existing clarifier, filtration, and backwash systems, rendering them inoperable. Pretreatment facilities would include pressure filters, absorption materials, and backwashing air blowers located within the footprint of the existing plant. Raw water pumped from the river would pass through the pretreatment facilities prior to entering the existing treatment system; and

WHEREAS, the total project cost is estimated to be just over \$3.5 million, including design and construction, with anticipated 75% FEMA grant funding and 25% CCWD matching funds; and upon future authorizing resolution by the Board of a final funding agreement with FEMA the District's Water R&R Capital Program would be used to pay costs above and beyond grant funds received from FEMA for design and construction of the project; and

WHEREAS, the Board of Directors of the CALAVERAS COUNTY WATER DISTRICT does hereby find that it is in the best interest of the Calaveras County Water District to amend the adopted FY 2015-16 CIP Budget accordingly.

NOW, THEREFORE BE IT RESOLVED, the Board of Directors of the CALAVERAS COUNTY WATER DISTRICT authorizes the addition of the Jenny Lind Water Treatment Plant Pretreatment Facilities Project, CCWD CIP # 11092 to the Capital Renovation and Replacement (R&R) Program.

BE IT FURTHER RESOLVED, the Board of Directors approves initial grant application costs estimated to be \$50,000 and adopts an amendment to the Fiscal Year 2015-16

Capital Improvement Program (CIP) Budget as set forth in Budget Adjustment 16-03, attached hereto and made a part hereof, and authorizes the Director of Administrative Services to record the appropriate accounting entries.

WHEREAS, The District needs to commit the total local match of \$939,500 for CCWD CIP #11092 and amend the Fiscal Year 2015-16 Capital Improvement Program (CIP) Budget to include an additional \$889,500; and

WHEREAS, the Board of Directors of the CALAVERAS COUNTY WATER DISTRICT does hereby find that it is in the best interest of the Calaveras County Water District to amend the adopted FY 2015-16 CIP Budget accordingly.

NOW, THEREFORE BE IT RESOLVED, the Board of Directors of the CALAVERAS COUNTY WATER DISTRICT adopts an amendment to the Fiscal Year 2015-16 Capital Improvement Program (CIP) Budget as set forth in Budget Adjustment 16-04, attached hereto and made a part hereof, and authorizes the Director of Administrative Services to record the appropriate accounting entries.
