<u>DISCUSSION</u>: Mr. Hampton addressed the Board and reported that staff has recently identified an immediate need to replace equipment plates in the membrane section of the Vallecito Wastewater Treatment Plant. He indicated that the equipment plates are usually good for 5-7 years but they are showing signs of failure and need replacement. Replacement cost for the membrane equipment is approximately \$130,000 and produced by one vendor, Kubota Membrane USA Corporation. Director Strange asked if the District will be setting aside the \$26,000 annually for future replacement costs of the equipment. Mr. Hampton stated that the costs will be budged accordingly.
