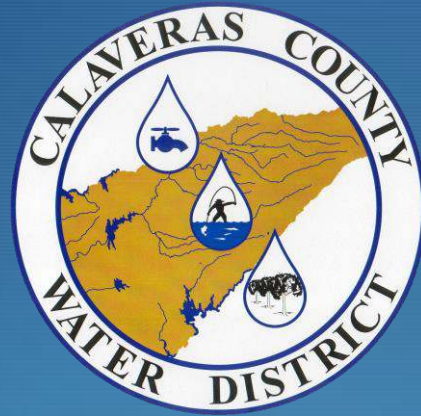

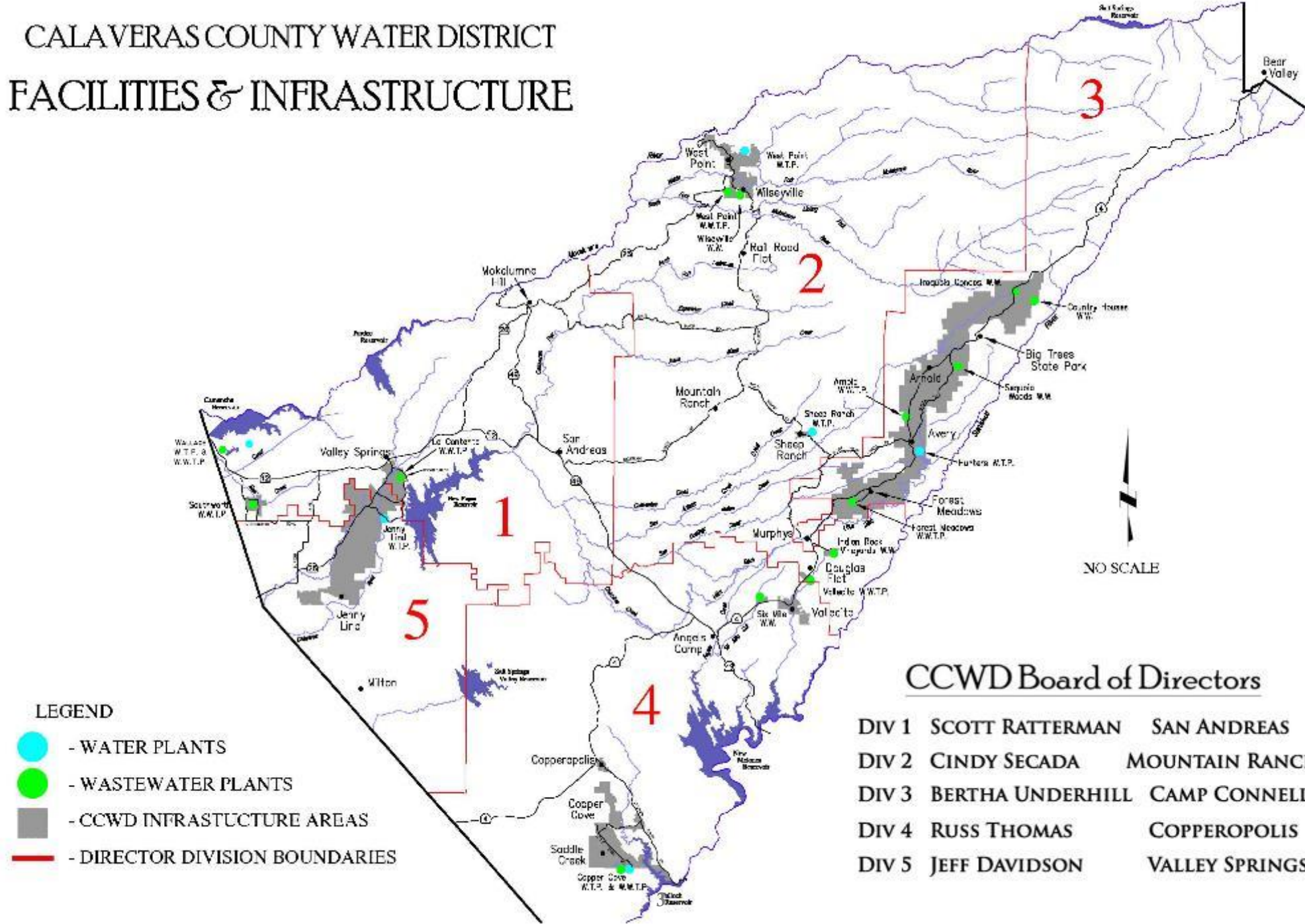


# CCWD Overview

- ◆ Special district formed in 1946
- ◆ 6 water plants, 12 sewer plants
- ◆ 65 full-time staff
- ◆ 13,000 water customers
- ◆ 5,000 sewer customers
- ◆ Water supplies
  - ◆ Mokelumne, Calaveras, Stanislaus, Groundwater

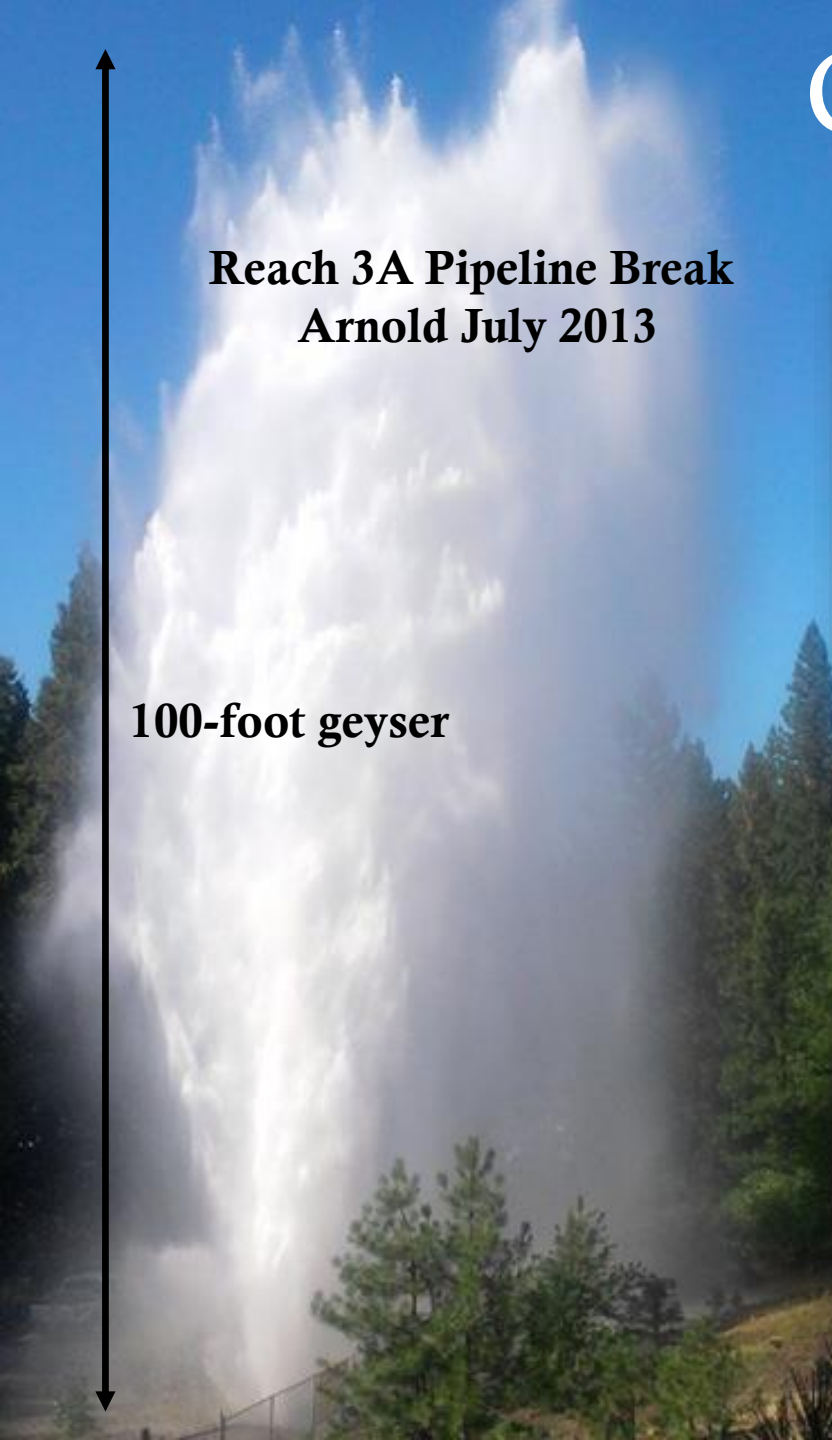
# Capital Renovation and Replacement Program (Capital R&R)

- ◆ Capital R&R rate increases took place in fall 2013 and 2014
- ◆ 100% of Capital R&R rate increase funds are reserved infrastructure improvements
- ◆ These funds pay for critical water and sewer projects throughout the County, including the Reach 1 Pipeline Replacement Project

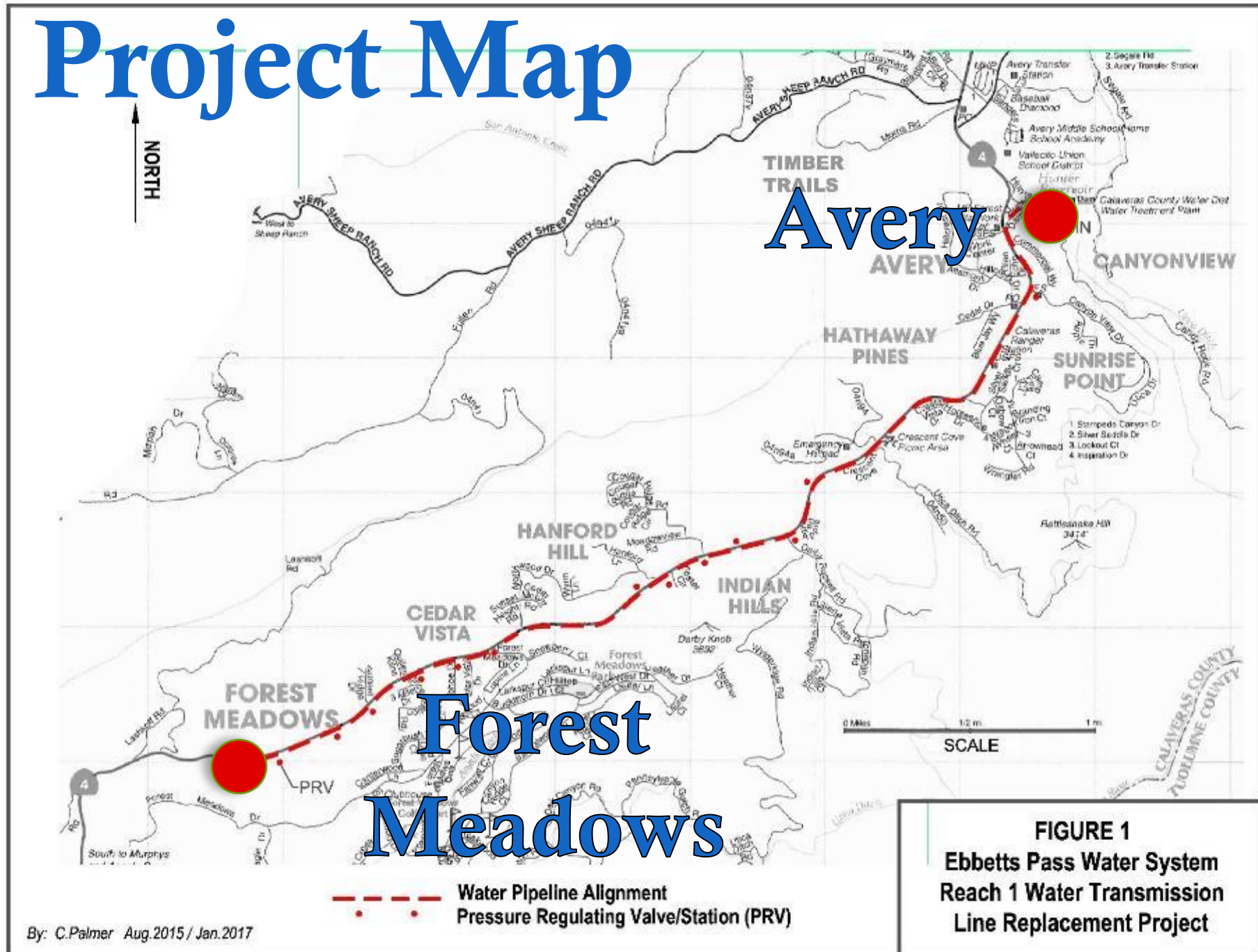

# Project Overview

- ◆ 23,000 feet (4.3 miles) of 12-inch Ductile Iron Pipe - 250 to 300-psi
- ◆ 1,300 feet (0.25 mile) of 8-inch ductile iron pipe
- ◆ Old pipeline built 1965 – New pipeline should last 75 years
- ◆ Starts at CCWD water treatment plant in Avery on Hunter Dam Road and ends just west of Brice Station Vineyards
- ◆ CCWD will strive to not interrupt water service for more than 1 day

# Project Cost

- 💧 Mozingo Construction won the project bid at \$6.7 million
- 💧 Including planning, engineering and construction management, the total project cost is \$7.5 million
- 💧 Funding comes from the Water Capital R&R Water Fund
- 💧 **These are your rate dollars at work!**

# Preliminary Project Schedule

- ◆ This is a two-year construction project
- ◆ Construction will begin on Monday July 8, following Fourth of July weekend
- ◆ The 2019 construction season will end in late October
- ◆ The 2020 construction season will begin in May 2020
- ◆ Project completion expected in fall 2020

# Primary benefits

- ◆ Improve water service reliability
- ◆ Improve water quality
- ◆ Reduce water loss from leaks
- ◆ Enhance fire flows
- ◆ Install infrastructure expected to last 75+ years



# Maintaining Existing System

- ◆ While the Reach 1 Project is being built, CCWD staff will ensure water quality in the area continues to meet state and federal standards.
- ◆ Staff will continue to maintain existing systems, despite increased workloads and disruptions.

# Minimizing Community Impacts

- ◆ Limit construction to 7 a.m. to 6 p.m. M-Thus., 7 a.m. to 3 p.m. on Fridays
  - ◆ Limited work could occur on weekends with advanced approval & notice
- ◆ Limit open trench excavation length; trench plates provided if public access needed
- ◆ Bypass pipelines to reduce service interruptions
- ◆ Consolidate construction equipment
- ◆ Minimize traffic delays and lane closures, when feasible
- ◆ Regular HOA/community meetings to keep residents informed
