1. PUBLIC COMMENT:

There was no public comment.

2. APPROVAL OF MINUTES:

The June 5, 2018 Minutes were approved as presented by a motion from Director Thomas, and seconded by Director Davidson.

3. NEW BUSINESS:

3a Presentation / Discussion Regarding Sewer Regionalization Option for Jenny Lind Elementary School (Robert Creamer, Engineering Analyst/Matt Ospital, Engineer, Weber Ghio Consultants)

Mr. Creamer discussed a proposed project, Calaveras Unified School District (CUSD) requesting regionalization for the Jenny Lind Elementary School sewer system. The suggested route would be along Berkesey Lane. CCWD would own the sewer system. CUSD has a grant to pay the expense of the sewer system regionalization to CCWD.

Mr. Logan discussed the origination of the tertiary class 3 facility at the elementary school and the reasons as to why they are no longer wanting to have the sewer system as an asset to the school district. The school district cannot afford the overall expense to own and operate a sewer system. CUSD has received an \$8M state grant to fund the regionalization project which includes; planning, construction and construction management of the project.

Mr. Thomas inquired about the school campus grounds and how much land it would free up for the school. Mr. Logan advised that the grant could also provide funding for additional lands to be purchased for spray fields for CCWD. Mr. Davidson inquired about the irrigation of the school grounds and ball fields. School grounds would be irrigated using CCWD water, not the treated water. They currently use the treated water as a subsidy to CCWD water for the ball fields.

Mr. Davidson inquired about the costs of the new pipeline. Mr. Ospital provided a brief breakdown of the systems that would be part of the project and would provide a cost per item breakdown at a later time. Mr. Logan advised that the overall cost would be \$6M. Mr. Davidson inquired if there were any additional capacity options available to help pay for the overall cost of this expansion and if there are any current violations that CCWD needs to be aware of. Rancho residents will not be put onto the sewers. After some further discussion, the Committee Members gave approval to continue to pursue options to find a working plan.

3b Presentation/Discussion Regarding Current Biosolids Disposal Practices and Costs, (Sam Singh, Engineering Tech)

Mr. Singh presented a brief slide show presentation on Biosolids Disposal Practices and the costs consisting of the history of the Title 40 Code of Regulations, Part 503 Ruling of the Clear Water Act, definition of and classifications of biosolids: Class A- removes all pathogens, using direct or indirect heat. No Risk of hazards or land restrictions. No risk of infectious disease or pathogens. Class B – Process of significantly reducing pathogens. 99.9% of pathogens removed using aerobic or anaerobic digestion using air or limestone methods. Class C – Exceptional quality – Enhanced version of Class A biosolids with reduced level of degradable compounds that attract vectors- no bugs, mosquitos, flies, etc.. CCWD produces sewer sludge-Class B.

The discussion also included costs to maintain and operate CCWD facilities as well as transportation costs to remove and haul sludge to landfills. Current sludge is hauled to Suisun City. Local County landfill does not have an ordinance and restricts CCWD from delivering biosolids to them. CCWD needs a designated area within the county to deliver biosolids. Will need an ordinance with the county for land application/landfill acceptable solids.

General Manager Eggerton briefly discussed the upcoming 2 by 2 meeting where the biosolids topic would be a subject of discussion. Other districts and septic haulers are also requiring these facility options.

Director Thomas inquired what type of biosolids are produced at La Contenta and could we merge all of the CCWD biosolids at this location to reduce hauling costs? The stress on the facility would be too great for that location to handle. After some further discussion, the Committee Members gave direction to staff to continue to find ways to reduce costs/fees for biosolids.

3c Presentation / Discussion of Ebbetts Pass Water System Big Trees Service Area and Updated Agreement with Snowshoe Springs for Water Service (Charles Palmer, District Engineering)

Mr. Palmer presented a slide show presentation on the background of the Snowshoe Springs request to replace their current water service with CCWD water and the challenges that CCWD faces to operate within this area. Snowshoe Springs would be utilizing the Big Trees Service Area water system. The request is for a domestic water supply and residential fireflow protection. The presentation included an overall view of the updates already completed to Big Trees and Reach 1 and concluded with discussion on future update projects including the master plan updates. Fire mitigation is the most critical updates that need to occur.

General Manager Eggerton briefly discussed the team project of CCWD staff Hazard Mitigation projects, Snowshoe Springs HOA and Weber Ghio Staff to resolve any issues and find commonalities to make all of these items coincide at the same time.

4. OLD BUSINESS:

There was nothing to report.

5. FUTURE AGENDA ITEMS:

EC 08/07/18

Director Thomas would like to see a comparison of the costs between the District costs of processing and hauling its sludge out of county for disposal and the annual costs of other agencies for producing sludge and their methods for disposal.

Director Thomas inquired about the status of the Copper Town Square Center where they have a sewer holding tank and if there are any bonds remaining on the original project to rectify their sewer pumping and hauling situation and connect the Center to CCWD facilities.

Director Thomas inquired about the meter size/fire flow/sprinkler issues to determine if we have a resolution. Currently being discussed in the Finance Committee, will provide findings at next Engineering Committee meeting. There is a ground-breaking ceremony at La Cobre Mina development in Copperopolis that could be affected by this.

General Manager Eggerton stated that CCWD will be adding operations staff presentations to the Engineering Committee meetings to provide information and concerns to the board for discussion.

SUMMARY

A presentation will be made by Mr. Oliver Tarap, Controls/Communications Senior Supervisor, that will cover a basic overview of the District in regard to electrical aspect including SCADA, SCADA radio communications, voice radios and backup generators. The second half of the presentation will cover current facility issues with the Hunters Dam Pump Station, Lake Tulloch's submersible pumps and remote system accessibility. Of significant concern is the Hunters Dam Pump Station that is outdated and in dire need of upgrades. Also, the Lake Tulloch's submersible raw water pumps need to be completed, installed and work off a variable speed control. Remote system accessibility improvements are recommended to help with SCADA control and future asset management programs.

Services for Unbuildable Parcel in Arnold

SUMMARY:

Mr. and Mrs. Cocco, owners of 1141 Sequoia St. in Arnold, CA have requested an exception to Section 21.E. of Article III of the District's Rules and Regulations Governing the Furnishing of Water and/or Wastewater Services which states, "Termination of water and/or wastewater services to a property is not allowable under this policy." As shown on the attached parcel map, the subject properties consists of two parcels APN 026-027-030 & -031. One lot is 0.01 acres and unbuildable. While zoned commercial (C-2-DC), the properties currently have only one single family residential structure. The properties have one active sewer connection and a second non-active connection.

Though the District has Resolution 2002-86 which established a policy relating to "Exceptions to Construction Standards" and "Fee Waivers," staff has determined that this resolution does not apply to this request for an exception to the District's termination of service policy, as the request does not involve the District's construction standards nor is it a request for waiver of fees. The District has other policies to assist customers for temporary suspension of services/billing situations where an event occurs that temporarily interrupts the need for service such as fire damage to a home that must be rebuilt. However, this situation does not fall within these parameters.

Due to the unique circumstances of this situation, which predates the current owners and effectively beyond their control, staff recommends allowing this individual exception to the District's policy regarding termination of service. The proposed exception would eliminate current bi-monthly sewer changes for the non-active sewer connection, but one active sewer connection would continue to be charged for the existing single family residential structure. Staff is taking this opportunity to obtain input from the Committee Members prior to bringing a proposal to the Board of Directors.

CALAVERAS COUNTY WATER DISTRICT RULES AND REGULATIONS GOVERNING THE FURNISHING OF WATER AND/OR WASTEWATER SERVICES ARTICLE III

APPLICATION FOR SERVICE RATES AND BILLING

The owner must notify the District at least forty-eight (48) hours (excluding weekends and Holidays) prior to the reconnection of the services. If an owner does not establish a reconnection within two (2) years, automatic termination of the suspension will occur and monthly service and consumption charges will be reinstated.

If any District facilities are found to be in use during such time as service has been suspended, owner will immediately become liable for the monthly water and wastewater service and consumption charges that would have been billed during the suspension period.

E. <u>Termination of Services</u>. Termination of water and/or wastewater services to a property is not allowable under this policy.

Resolution 2010-78 November 23, 2010

E.1 Granting and Accepting Capacity Transfers.

Owners of two parcels within the same CCWD service area as defined below may request the ability to transfer capacity from one lot to another provided:

- a. Both lots involved must be:
 - i. Owned in fee title per County of Calaveras Recorder's Office by the same owner at the time capacity transference.
 - Located in the same CCWD service area hereby defined as an area served by the same CCWD distribution and/or collection plants.
 - iii. Designated for single family residential construction only. Capacity transfer is not available to multi-unit or commercial properties.

RESOLUTION NO. 2002 - 86

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE CALAVERAS COUNTY WATER DISTRICT RESCINDING PROCEDURE RELATING TO "VARIANCES" AND ESTABLISHING POLICIES RELATING TO "EXCEPTIONS TO CONSTRUCTION STANDARDS" AND "FEE WAIVERS"

WHEREAS the Calaveras County Water District has in the past allowed consideration of requests for "variances" in the application of its standards, policies and fees based primarily on the alleged financial impact upon individual applicants; and

WHEREAS the past practice is inconsistent with both the District's business and the applicable law.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Calaveras County Water District that the past procedure for consideration of requests for "variances" in standards, policies and fees is hereby rescinded.

BE IT FURTHER RESOLVED that the policies regarding "Exceptions" (Attachment One, incorporated herein by reference) and "Fee Waivers" (Attachment Two, incorporated herein by reference) are hereby adopted and shall be universally applied to all applicants.

BE IT FURTHER RESOLVED that District staff shall develop, and present for Board review, procedures implementing the above-referenced policies.

CALAVERAS COUNTY WATER DISTRICT POLICY REGARDING EXCEPTIONS TO STANDARDS. RULES AND POLICIES

It is the express policy of the Calaveras County Water District that all of its standards, rules and policies be equally and fairly applied to every person or entity affected thereby. Because of the potential for disparity of treatment, exceptions to the standards, rules, and policies are generally disfavored and shall not be granted unless all of the following conditions are satisfied:

- 1. Granting of an exception shall not discriminate in favor of, or against, any applicant for the exception or any other District customer.
- 2. An exception shall not be considered for purposes of financial benefit or relief.
- 3. Exceptions may be considered only for purposes of protecting significant environmental or aesthetic natural features, or for allowing reasonable beneficial use of real property for residential purposes.
- 4. Exceptions shall not, in any way, have the effect of establishing substandard facilities or services, or result in increased District costs.

All applications for an exception to District standards, rules and policies shall be reviewed in accordance with administrative guidelines promulgated by the General Manager.
