## SUMMARY:

On December 29, 2015, the Federal Emergency Management Agency (FEMA) issued an approval letter for the Jenny Lind Water Treatment Plant Pretreatment Project (HMGP #4240-1-1) with a total eligible cost of \$3,758,000 and a federal share of \$2,818,500, based upon a 75% federal grant and 25% local match.

Since the grant funding was approved, FEMA and District staff have increased the scope of work and extended schedules in order to comply with federal NEPA requirements with special regard for preservation of cultural resources on the site. On May 23, 2018, FEMA issued an Adverse Effect Notification due to the unanticipated discovery of Native American artifacts on the project site during the early stages of construction. In assisting the District to attain compliance under Section 106 of the U.S. National Historic Preservation Act, FEMA and Cal-OES staff have been extremely helpful and proficient in working with archaeologists, tribal representatives, SHPO and ACHP in securing approval of a project specific archaeological treatment plan and establishing protocols for monitoring and reporting for cultural resources during construction ground disturbing activities.

As of September 26, 2018, the District will have spent \$160,000 for archaeological services including development of the treatment plan, preparing reports and full time archaeological and tribal monitoring of all construction ground disturbing activities. The District expects archaeological and tribal monitoring cost of \$75,000 for October, November and December or a project total of \$235,000.

The District has incurred other extra costs on the project for:

- 1. A difference of more than \$500,000 in actual construction costs (compared to original estimate) including extra costs for replacing the main electrical service to supply electrical loads for the project
- 2. Delay costs of \$67,000 claimed by Contractor for more than 70 days of work stoppage earlier this summer relating to the Adverse Effects Notification
- 3. Additional engineering and consulting fees of \$350,000 for design and construction phase services

As of September 2018, the District has fully obligated and/or spent approximately \$4,358,000, which includes \$3,500,000 in funds assigned to the construction contract. Due to unanticipated costs, the project cost will exceed the original budget in the grant application, and the District is responsible to pay all project costs not previously approved by FEMA. The funds to cover these costs would have to come from the Capital Renovation and Replacement Fund, which would cause delays or reprioritization of other important projects on the CIP list.

Fortunately, on September 12, 2018, Cal OES informed the District additional disaster funds were available and invited the District to submit a request for additional grant funding from FEMA. With costs exceeding the original budget for the project, the District welcomed the opportunity to submit for additional funding. On September 12, 2018, the District submitted a letter to Cal OES requesting a project funding increase of \$831,000, with a revised project budget totaling \$4,549,000. The original and revised budgets are summarized below including utilization of all contingency funds.

On September 18, 2018, Cal OES informed the District an updated local match commitment letter would be required as part of request for the project budget adjustment. Per CCWD policy, the CCWD Board of Directors must approve CIP budget adjustments and local funding match commitment letters.

These additional grant funds are not guaranteed, and the District is competing for these funds with a number of other agencies.

## FINANCIAL CONSIDERATIONS:

The District is requesting a budget adjustment of \$831,000 for the Jenny Lind Water Treatment Plant Pretreatment Project in the Water Capital R&R Fund (Fund 125). This will increase the total project cost to \$4,549,000.

**WHEREAS,** on December 29, 2015, the Federal Emergency Management Agency (FEMA) approved the Jenny Lind Water Treatment Plant Pretreatment Project (HMGP #4240-1-1R) with a total eligible cost of \$3,758,000 and a federal share of \$2,818,500, based upon a 75% federal grant and 25% local match; and

**WHEREAS,** since the grant application was initially approved, FEMA and CCWD have undertaken substantial additional efforts, increased scope of work and extended project schedules in order to comply with federal National Environmental Protection Act (NEPA) requirements; and

WHEREAS, on May 23, 2018, upon discovery of Native American artifacts during the early stages of construction, FEMA then issued an Adverse Effects Notification and has subsequently worked with Cal-OES and CCWD to attain compliance under Section 106 of the U.S. National Historic Preservation Act including necessary coordination with archeologists and tribal representatives to secure approval for a project-specific archaeological treatment plan for monitoring cultural resources during construction; and

**WHEREAS,** complying with NEPA requirements, archeologist and cultural resources monitoring on the project and associated delays to the construction schedule have increased costs and budget requirements by \$831,000; and

**WHEREAS,** funding is available in the Water Capital Renovation and Replacement Fund (Fund 125) for the project budget increase; and

WHEREAS, the CCWD Board of Directors does hereby find that it is in the best interest of the Calaveras County Water District to amend the adopted FY 2018-19 CIP Budget accordingly for the Jenny Lind Water Plant Pretreatment Project, CIP #11092.

**NOW, THEREFORE BE IT RESOLVED** that the Board of Directors of the CALAVERAS COUNTY WATER DISTRICT adopts an amendment to the Fiscal Year 2018-19 Capital Improvement Program (CIP) Budget as set forth in Budget Adjustment 19-01, attached hereto and made a part hereof, and authorizes the Director of Administrative Services to record the appropriate accounting entries.

# SUMMARY:

On December 29, 2015, the Federal Emergency Management Agency (FEMA) issued an approval letter for the Jenny Lind Water Treatment Plant Pretreatment Project (HMGP #4240-1-1) with a total eligible cost of \$3,758,000 and a federal share of \$2,818,500, based upon a 75% federal grant and 25% local match.

Since the grant funding was approved, costs have increased significantly due to an increased the scope of work, cultural resources monitoring on the project and associated delays to the construction schedule, as well as increases in construction costs and engineering consulting fees.

On September 12, 2018, Cal OES informed the District that additional disaster funds were available and invited the District to submit a request for additional grant funding from FEMA. With costs exceeding the original budget for the project, the District welcomed the opportunity to submit for additional funding. On September 12, 2018, the District submitted a letter to Cal OES requesting a project funding increase of \$831,000, with a revised project budget totaling \$4,549,000. The original and revised budgets are summarized below including utilization of all contingency funds.

On September 18, 2018, Cal OES informed the District an updated local match commitment letter would be required to be considered for additional grant funding. Per CCWD policy, the CCWD Board of Directors must approve CIP budget adjustments and local funding match commitment letters.

It is important to note that additional grant funds are not guaranteed, and the District is competing for these funds with a number of other agencies. If CCWD is not awarded additional grant funding, it is the District's responsibility to cover any additional costs that are not otherwise funded by FEMA.

## FINANCIAL CONSIDERATIONS:

The District is requesting a budget adjustment of \$831,000 from Cal OES for the Jenny Lind Water Plant Pretreatment Project. Applying the 75% federal grant and 25% local match, CCWD will need to commit an additional \$207,750 in local matching funds, which increases total matching funds to \$1,137,250. The requested federal share will increase from \$2,818,500 to \$3,411,750. The revised total project cost will be \$4,549,000.

**WHEREAS,** funding is available in the Water Capital Renovation and Replacement Fund (Fund 125) for the commitment of local matching funds; and

**WHEREAS**, the CCWD Board of Directors does hereby find that it is in the best interest of the Calaveras County Water District to authorize the General Manager to sign a local match commitment letter, per Cal OES requirements, for the Jenny Lind Water Plant Pretreatment Project, CIP #11092.

**NOW, THEREFORE BE IT RESOLVED** that the Board of Directors of the CALAVERAS COUNTY WATER DISTRICT authorizes the General Manager to sign a local match commitment letter for \$1,137,250, which is the District's 25% share of the \$4,549,000 total project cost.
