## BOIL WATER NOTICE

Este informe contiene información muy importante sobre su agua potable.

### BOIL YOUR WATER BEFORE USING

**Failure to follow this advisory could result in stomach or intestinal illness.**

Due to a major main water line leak resulting in a water outage in the Big Trees Village area, the State Water Resources Control Board, Division of Drinking Water, in conjunction with the Calaveras County Environmental Health Department, and Calaveras County Water District (CCWD) are advising residents of the Big Trees Village area, served by CCWD, Ebbett's Pass Water System #0510016 to use boiled tap water or bottled water for drinking and cooking purposes as a safety precaution.

**DO NOT DRINK THE WATER WITHOUT BOILING IT FIRST.** Bring all water to a boil, **let it boil for one (1) minute**, and let it cool before using, or use bottled water. Boiled or bottled water should be used for drinking and food preparation **until further notice**. Boiling kills bacteria and other organisms in the water and it is the preferred method to assure that the water is safe to drink.

- An alternative method of disinfection for residents that are not able to boil their water is to use fresh, unscented, liquid household bleach. To do so, add 8 drops (or 1/8 teaspoon) of bleach per gallon of clear water or 16 drops (or 1/4 teaspoon) per gallon of cloudy water, mix thoroughly, and allow it to stand for 30 minutes before using. A chlorine-like taste and odor will result from this disinfection procedure and is an indication that adequate disinfection has taken place.
- Water disinfection tablets may also be used by following the manufacturer's instructions.

CCWD will inform you when tests show that water is safe to drink and you no longer need to boil your water. We anticipate resolving the problem within next two-to-three days.
